Placement costs - still hovering right around the same amount of 1.1 or 1.2 million. In terms of the cost savings that was requested, we are well over half a million.

Building issues – the building is scheduled to be paid off soon, which is great and will be a major cost savings. Might this be a good time to look at roof, carpet, hvac, etc?

Levy – target next November for the first time.

Miscellaneous – new hire, business relations in WIOA. 3 new foster homes were licensed in October so we are now at 12. One home has a baby, and the other is preparing for one. A handful of others are close to becoming licensed but hopefully they will be by the end of the year.
