Ohio State is considering backing out of Agriculture Education. | Easter Seals (9:00am) | Lauren Holly and Sheila Dunn– Easter Seals. Lauren and Sheila were here about a year ago to talk about the need for adult day care in Sandusky County. They are very close to having their facility completed. They have a great deal of interest in the facility and what they can provide. There is some confusion on the difference between being an adult day care and the senior center. They are there to assist seniors that need to be cared for while their care givers are working or unavailable. They are not there for seniors that are self-sufficient. Commissioner Reiter asked if the facility would allow people to bring seniors in on a flexible schedule? It can be set up on a routine basis such as every Tuesday and Thursday or only one day a week to five days a week. They are not open on the weekends and they are not a 24 hour facility. It does help with social interaction as well. They can serve 40 individuals a day. The staff is based on how many individuals are in the facility per day and that is mandated by State terms. They will also move their current offices to this location. Last fall they worked with the hospital regarding fall prevention. They work with seniors who tend to fall or are fearful of falling. They wanted to come in today because they have had some great resources but wanted to ask the Commissioners if they know if there are resources in the area that they have missed in order to create more relationships. They are working with a few local foundations for funding assistance. Commissioner Reiter asked if they had talked to Promedica. They have them on the list to talk to, but Promedica did donate some used furniture for the facility. They are hoping to receive some Corporate sponsors to assist in buying furniture. 
