The Kay E Reiter Attended by meeting was well attended. The group was separated by Theresa Garcia Commissioners counties, cities, townships etc. to discuss issues. Each group presented two questions to the legislators on the panel for feed-back. Feed-back was not as positive on some questions as anticipated. There was discussion on motivating individuals to come to Ohio for employment and how you entice them. Commissioner Zimmerman attended the FCFC meeting Russ Zimmerman yesterday afternoon. There was a couple present who purchase properties and one is on Tiffin Street. They fix them up and rent them out to individuals that need assistance. They want to help with those individuals that need some help. They had one couple live in a home for a year rent free. Commissioner Zimmerman was unsure where the funding was coming from to make these purchases. Cathy Glassford, FCFC Director, presented

	the finance report to the committee for review. There is one fund that may have a \$28,009.00 deficit in 2020 so they will need to change funding and budget to compensate for this deficit. They are waiting to see the State Budget to see if this will happen. They are trying to build on their parent's night out program. They are also supporting the State to raise the smoking age to 21 years of age. Nate Koenig was there to talk about the Foster program. They started with nine Foster homes at the beginning of the year and now currently have 21 Foster homes. John Husted is talking with Nate Koenig and would like to use Sandusky County as a pilot program to share with the rest of the State. Cathy asked Commissioner Zimmerman if there was a decision on increasing her appropriation for next year. The decision will not be made until we are deeper in the budget process for 2020.		
	Commissioners all attended a special OSS Board meeting. After several candadite interview sessions, the Board moved forward with hiring Kathleen Rocco from Cuyahoga County. She has been in this environment in Cuyahoga County for years. She will start September 9th. They would like to get her here sooner but she is relocating. Commissioner Reiter and Administrator Garcia are meeting with Tim Wasserman, current Director, to discuss the transition to the new director. The Board also approved a letter to be sent to the Seneca County Health District and Tunnel Hill regarding the resolve of the host agreement and the settlement signed by all parties.
