* Denotes action needed

- We are working with our commercial cleaner to set-up new schedules (as departments are starting to return to county buildings), and have negotiated a new contract, the existing contract expires on May 31st 2020.
- We have finished installing the plastic barriers/shields in the departments that have direct contact with the public. 2
- We have ordered an Electrostatic disinfectant spraying equipment. (Costs redeemable). 3
- The service center punch list for the HVAC controls project has been completed and has been reviewed by architects/ engineers. To complete this project we will need delivery of all the close-out documents and as-built drawings. 4
 - working with the JDC administration and Poggemeyer's group to get this project started. We The JDC controls proposal has been reviewed by Poggemeyer and JDRM. We have been have the kickOoff meeting scheduled for Thursday. 5
- We have been working with the Poggemeyer group on finishing up plan specifications on the new building department and F.M. projects. The pre-bid meeting will be on May 27th, site visits May 28^{th} and 29^{th} and the bid opening on June 9^{th} 9
 - The new Veteran's Park arch has been installed and they are finishing up with the stone
- KDH has finished the Veteran's Park concrete sidewalk repair work, and moved the signs to their new locations
- We are in the process of scheduling the installation of the commissioner's front door, and handicap door openers with Commercial Glazing, (Front Dorr install tentative June 8th). 6
- We are working with GLCAP on the CDBG funded Sandusky Co. Board of DD Senior Center kitchen renovation project. 10.
- We have scheduled the installation of a new security wall and door on the second floor of the Woodville Court.
- Additional ice breakers to protect the new ADA ramp area have been installed
- The commissioners building roof gutters were repaired last week. This should alleviate the water issues near the side entrance door.
 - We are working with the BOE on installing a security wall at their front counter location. Contractors to visit the job site this week. 14.
- Northcoast security is installing electric strikes on some doors at the BOE in prep. for their access control up-grades.
