	The Imagination Library project that Fran DeWine has been talking about was discussed and the cost of the books along with how many children would benefit in the County. The group talked about how many of the groups are already sending books and providing books to children in the County. Some areas have no library for the children to use so they have already been assisting. They may do the program in areas that need the assistance but not the whole County. The Foster Care program was talked about and how many additional Foster home's we have in the County. There was talk about a program called Bridges. This program assists children who age-out of the system and need somewhere to go. The State is offering additional funding for wrap-around. There is a training they need to attend and as long as they attend they can receive \$10,000.00.		
	Commissioners all attended a meeting at SCEDC regarding Situational Distress Zone and a petition that was requested from the Commissioners. Bob Gross and Kerrie Carte (via the phone) were also in attendance. There was some questions on what the pros and cons were and if it would negatively impact the County. It can help with expanding an industrial park in Fremont and other opportunities. Sandusky County is sitting on the buddle of being considered in distress. Citizen	Jim Moyer came in and asked to speak with the Commissioners. Commissioner Reiter invited him to speak. Jim was the former Sandusky County Engineer and has retired. He wanted to come in to thank Commissioner Reiter and Miller for passing the additional permissive tax funds when they did. He felt it was important to back them up on this decision in the up-coming election. He also gave his opinion on starting a weight limit program and hiring a deputy to enforce weight limits in the County. He does not feel it is necessary.		
FCFC	Cathy Glassford – FCFC. Cathy came in for her regular meeting with the Commissioners. Megan Kimberlin, Wrap-Around Clerk, came in with Cathy for the meeting. Cathy plans on meeting with Board Chairs to look at finances to see what the Department can afford to do when Cathy retires. She does not have a specific date for her retirement yet but most likely at the end of the year. The State is going to host regional training for Wrap-Around and if they attend they could get up to \$10,000.00. Cathy and Megan plan on attending the trainings. The funds will come from the State FCFC budget. The State FCFC Director is focusing on multi-family functions and prevention. There are many collaborative projects happening in the County. They are talking a lot about respite care to assist in keeping families together. There has been talk about training Foster Parents in respite care too. There has been some funding coming in for schools. This could help with the project Sandusky County DJFS is working on to have an outreach worker in house at the schools. Megan will be training this person in wrap-around to help with the program. They have a social worker in the schools now who will be trained in wrap-around. Megan has been doing trauma training in Columbus to help understand what has happened to some of the children who have emotional challenges. She is also trying to reach out to Seniors who are raising children to help them understand some of these issues. 	children and families in stressful situations. Commissioner Reiter asked who you would call if you come across an individual, homeless, hungry and in distress. The question is if there is a 24 hour call line to get assistance for someone who has nowhere to go. There seems to be a gap on who to call in an immediate need situation. It is something that needs to be discussed and worked on with different organizations. It is so important to engage the community. They also talked about the imagination library and how the program works. The suggestion was to make sure the different organizations are working together on the books being sent to families.
