A news release was sent out by the Commissioners with limited public access to County Offices. Elected Officials will make their decisions if they feel it should be different. Judges are looking case by case and considering whether they can reschedule or not. Lisa Kuelling, EMA Director, updated the Lisa Kuelling - EMA Commissioners on the virus statistics. There were 14 Director confirmed cases and 159 being tested. Primarily all counties with cases are far enough away. The jail is no longer allowing visitation. If they have to let someone in they are asking them health questions and taking temperatures. They have good plans in place. They are looking for disincentive wipes for cruisers. Jaime Wolf, HR Specialist, will contact the jail about disincentive wipes. There has been questions regarding an event having over 100 people. ORC states the Sheriff will need to shut this down if necessary. K-12 schools have been closed for three weeks. State staff are working from home. The April EMA exercise is up in the air at this time. EMS was asked by one of the nursing homes to complete a health questionnaire for their staff to answer. Bethany Brown, Health

	Bethany Brown, Health Commissioner, reviewed the procedure for when quarantining individuals She believes it will be important to flatten the curve and it is in the best interest of everyone. 	Commissioner, is going to check in to this request. Counties with homeless shelters need to come up with plans on what to do with someone testing positive. The Health Department would need to handle finding a place to quarantine. We should find a place for travelers, homeless, etc. This may be a little way off. We need to keep up with State procedures. The State is watching local EMS PPE needs. After going back to look at the school shut down. There is some concern about what happens if they are down longer. When a National Emergency is declared more funding will be available. When there is a big outbreak you won't be tested just treated and self-isolated.
