Commissioner Zimmerman made mention that the Commissioners believe that they should not be placed in the middle of the orders that the two Judges are placing. Beth Tischler stated that this order is not reflected in the Supreme Court issues. Beth mentioned that the Commissioners should establish the wages for the probation officer. Judge stated the budget amount was approved when doing the 2020 budget and states that it doesn't matter who receives the wages it was budget at \$22.00. Judge Fiser mentioned that the new hire does not need health insurance and so that saves the county \$18,000. Commissioners stated we do not take that into account when setting wages and pay scales because that can change. Judge Kolesar joined the call and Beth Tischler summarized the first few minutes of the meeting. Beth pointed out that the Chief's joined the meeting due to the security issue they believe Woodville Court has with the lack of a probation officer present daily and that makes them responsible for the calls/security. Commissioner Zimmerman summarized that the Commissioners are not here to make a decision whether Judge Fiser can hire but strictly wages. Judge Kolesar discussed that he feels the wages are not fair to his staff who have been their longer and will now be making less due to the 40 hour and 37.5 hour difference with the two courts. Chief Whitehead stated that the west end of the county elected Judge Fiser and he believes she is doing a wonderful job and should not be micromanaged. Judge Kolesar stated with the motion that was made that they will just have to deal with this come budget time for next year.
