- New HVAC unit for the I.T. server room is underway. The condenser unit was set yesterday they will complete installation this week.
- Commercial Glazing re-worked the automatic door openers push buttons yesterday. We are quoting one additional opener for Recorders office. 7
- addressed the building department should be able to move in also, most likely by the end of Construction at the F.M. and Building Department projects are coming to a close. Facilities management has moved into our new office and after the punch list items have been this week....(walls painted, electrical work completed) 3
- The Adult Probation offices at the service center moving forward, however we are still having some issues with the boilers. The new chiller is in place, and they are working on the piping. The flooring, Aiphone system, and punch list need to be completed before Adult Probation can take occupancy. 4
