They had 22 trips canceled last year. They only have 15 tentatively scheduled for this year. Dave Thornberry had volunteered to take some time off, unpaid, to help with the budget. They talked about the basketball tournament they had scheduled and canceled last year. They would like to reschedule but probably not until 2022. They do have a link on Destination Toledo for the Sandusky County Visitors Bureau for those who go to that site for tourism information.		
	Commissioner Zimmerman attended the LEPC meeting by teleconference. There wasn't much on the agenda. They talked about the inflatable light mechanism used at the Keegan Farm fire in Clyde.
