They are Attended by finishing the outside of the two Fifth street buildings and Commissioners completing punch lists for the inside. They are going to have a meeting on Tuesday to discuss change orders for those buildings. They are still waiting on a plan for the fire alarm replacement in the jail. There will be a meeting this afternoon to discuss the jail project. Commissioner Zimmerman attended the Soil & Water Russ Zimmerman Board meeting last Friday. Financially they are doing well and they are waiting for the H2Ohio funding to come. They are hoping the Governor will fully fund this project. They reviewed several programs they are providing to the agriculture society and how many acres they are covering with the programs. CASA	Michelle Hess – CASA. Michelle joined us by teleconference to update the Commissioners what CASA is doing and how they are managing during the pandemic. They train people every day to work with families to advocate in court. Michelle explained exactly what their role is in court for the families. Their goal is to help families and children's voices be heard to give them the best outcome to live a healthy, safe life. Last year they advocated for 231 children with 62 volunteers. They are expecting their cases to increase when schools go back into session full-time. They have several more volunteers and that will be a big help. They have another training class for volunteers coming up in April this year. Commissioner Zimmerman asked why numbers for assistance goes up when school is in session. Michelle noted that most of their referrals come from teachers and counselors that work with these kids every day. Virtual school does not give them the opportunity to see in person how the families are really doing. She has contacted the schools they work with on how to recognize signs of neglect or abuse. She also talked about teachers passing along information to the next teacher for students in their class that have had issues the prior year to keep an eye out for them. Commissioner Miller asked what the average age is of the children they work with. Michelle stated depending on the family the ages vary. The types of abuse and neglect is not typical only for Sandusky County it is all over. Michelle noted 80% of their cases right now are due to parental drug abuse.
