They reviewed the original contract on how this happened. The contractor is going to change out the switches so they all match. There were several other change orders discussed and what responsibilities were the County and what responsibilities were the contractors. There is minimal change order dollars that the County will have to be responsible for. Commissioners all walked through the dungeon hallway Russ Zimmerman at the courthouse with the Visitors Bureau. They want to Scott Miller hang some historical photos in the hallway leading to the Charles Schwochow

dungeon. The Commissioners are good with the idea and think it will be a nice addition to the tours. They also want to hang pictures in the cell areas in the Old Jail.

	Commissioner Zimmerman attended the Visitors Bureau meeting. They are trying to come up with additional activities that work with Covid-19 guidelines. They are thinking of conducting some activities at the fairgrounds by the log cabin, maybe even an outdoor meal or something in the art barn. They have 17 tours scheduled this fall. Dave Thornberry and Brenda Havens, Visitors Bureau staff, were nominated for the Community Service award for the Chamber of Commerce annual awards. The Board reviewed the budget. They adjusted the budget to take in to consideration the PPE grant they are receiving. Dave Thornberry made a presentation on the current web page. There was an issue with an ad that popped up that should not have been there. The current web manager noted they could help stop that from happening. Dave felt he could do the same thing in house for much less. The Board agreed to have Dave handle this. The Commissioners and the County Administrator attended the virtual EDC annual meeting. The presentation showed an uptick in employment and manufacturing despite the pandemic. The statistics were very impressive and looks good for the County. Commissioner Zimmerman attended the ribbon cutting ceremony for PT Services Rehab. The new building was renovated and will serve the community well. They will be opening next Monday. 	They worked 115 cases and confiscated several different types of drugs and some property. BCI helped on some cases with drones and other equipment at no cost to the County. Arrests were down in 2020 but he feels they will increase this year. Commissioner Miller asked if drug traffic changed due to Covid. Mark did not feel this had much of an affect. Commissioner Schwochow asked if they felt they were making a dent in the County drug issues. They work with other counties and they feel they are making a dent in the drug world in Sandusky County. Beth plans on using some of the statistics as a PR event to promote the levy renewal. Commissioner Schwochow asked about Beth meeting with Brian Woods from the land bank to discuss land bank needs. She does plan on meeting with him they just don't have a time scheduled yet. Commissioner Zimmerman mentioned a comment that was made at a Township meeting regarding contracts being held up at the Prosecutors office. Beth talked about the timing on when she received the contracts and how they turned them around.			
Sandusky County Patriots	Michael Roob came in representing the Sandusky County Patriots. He had several other members come in with him. Michael came in asking the Commissioners to pass a resolution making Sandusky County a sanctuary county. Their request is to solidify the second amendment. In the meantime it sounds as if the State is working on making Ohio a sanctuary State. He talked about other counties who have passed resolutions making their counties a sanctuary county and some that have noted they will not be passing a resolution. Commissioner Schwochow noted they are not passing new laws for the county but they will stand up and uphold the constitution and they will all stand up to the oath they took as elected officials. Some documents were presented with information from other counties on why they approved their resolution. The resolution that was presented to Commissioner Schwochow to approve was passed along to the Prosecutor for an opinion. Commissioner Schwochow noted we are all concerned with laws being presented at State and Federal levels and how they will affect law abiding citizens who own guns. Commissioner Zimmerman presented a letter to the group stating the Commissioners swore by oath to uphold second amendment rights and they will stand by	Michael Roob – Sandusky County Patriots		

	those rights. The group was told they are welcome to present the letter from them to any organization they feel necessary.		
Sheriff	Chris Hilton – Sheriff. Sheriff came in for his regular meeting. Sheriff did not have much to update. He was also able to speak to the Patriots group before he came in for his meeting. Sheriff will be changing security supervisor on March 8th. Stephanie Patterson will be taking over as Supervisor. He made a change in his drug task force staff representative. His road patrol is down by one and he has an open spot. He has had to make some moves to cover his sex offender office and foreclosures as they have both seen an increase in both areas. Sheriff attended an association meeting last week and they did discuss weather "emergency" language. They are going to work on these changes for all the counties but at this time will continue to use this until they come to an agreement on changes that will continue to keep citizens safe.
