- 1. The Law library, at their next meeting, will be discussing the new conference room project and developing a scope of work which we can then use to secure quotes.
- 2. Courthouse elevator has been repaired with the installation of a new light curtain.
- 3. We have submitted the C.D.B.G. application for the up-grading of the courthouse basement restrooms to comply with ADA standards. We are also working with GLCAP on the installation of the sidewalks at the Service Center.
- 4. Burkett Electric are securing prints for permits for the new service & generator at the F.M. shop.
- Construction at the F.M. and Building Department projects are complete, waiting for close out documents.
- 6. We are working with I.T. to finish up the cameras and install the monitor screens at the Service Center. The chiller has been started, however still working through some control issues and one VFD repair. Tentative schedule of May 5<sup>th</sup> for equipment training.
- 7. Removal of the wallpaper and painting of the Economic Development wing is complete and the carpet in being installed.
- 8. Sheriff Office project has been going forward with most of the new VAV's installed and starting to replace the air handling units (working on last one presently). We are working with PDG and the mechanical contractor on a list of change orders and additional up-grades.

#### 2021 Variables and Updates

- Federal Impacts:
  - Centers for Medicaid and Medicare (CMS) finally approved Ohio Department of Medicaid's Appendix K submission from November. This payment was sent to providers the second week of April. All active providers were eligible for this relief which was based on a percentage of claims from fourth quarter calendar year 2020. Local county boards are contributing \$24 million to draw down an additional \$54 million through federal Medicaid match. This is the first statewide COVID support issued to all service providers and not just a targeted service provider.
  - O The American Rescue Plan, while still not final in its implementation, is not intended to change any county board of DD's budgets or work. All enhancements will be geared towards the state and state departments to implement and manage.
- State Budget Impacts:
  - Ohio's unprecedented measure and announcement in December to reconcile calendar year 2017 and 2018's county board cost reports were reconciled, and checks received. No updates on the calendar year 2019's audit timeline. SCBDD's settlement will offset the expense for the provider relief payments approved in Appendix K (above). 2018's audit reflects the first since SCBDD fully privatized. This audit reflected a \$84,204 settlement rather than historical settlements that have fluctuated by several hundred thousand year-to-year and is likely more in line with future audits. In comparison, 2017's settlement was \$211,327 and reflects a partially privatized calendar year. DODD also recently announced they gave county board's their portion of their reconciliation (from GRF match) resulting in in unexpected variances.
  - Discussions and lobbying are actively occurring to increase Medicaid waiver rates through state GRF funds. The House did not support this in their proposed budget.
- Service Impacts:
  - Adult Service Rates: Enhanced COVID service rate changes for all day program services have been extended indefinitely and will likely be tied to state ODH health orders limiting service capacity.
  - Restrictions remain in place for all day program services for groups no more than 12 individuals. This increased last quarter from 10 to 12.
  - O Providers continue to struggle with staff shortages, overtime, and fixed overhead costs (for day and transportation providers) with unstable and unknown rate structures and daily/weekly attendance. Providers are reporting an alarming number of staff shortages and sentiments that the shortage is dire and 'worse than during COVID'. Provider business and service sustainability and stability continues to be closely monitored and SCBDD is working collaboratively to strategize with providers on the best ways to support them and ensure services.

**COVID Updates:** Infection and exposures have dramatically decreased with no isolation, quarantines, or program closures happening in several weeks. Gradual increases in in-person meetings are occurring. More people are beginning to return to programs as site capacity allows.
