Placement Costs –

- a. County costs continue to remain steady, but will still be less than last year from county. Monthly requests have averaged around \$70k.
 - i. Invoicing for costs only and not the average rate mandated by state has saved this year: \$284,790.75
- b. Current custody: 32 (34 last month)
 - i. One child adopted and one child custody went to a kin care provider.
 - ii. 30 days to family work continues.
- c. Director's workgroups- placement costs, and treatment foster care work continues. Moving forward with the treatment foster care program as a tri-county collab, this may mean a shared position to run this program. Continuing to work on rising placement costs and as much as we can to keep costs down.

II. Building status

- a. Covid: Monday, we are going to mask up the staff. Earlier this week required CS and CC staff to mask in homes.
- b. Administration did a tour of probation
- c. Sidewalks poured, Children Services staff are so excited and very thankful for that sidewalk!

III. Budget

- a. Staffing
 - i. Positions are being filled, upskilling our staff
 - ii. Although continue within our budget, things continue to be tight. One thing we have been hassling with is the state procurement process restricting us in purchasing a vehicle.
- b. Family first preservation services act requires after care services, and comprehensive assessments every 90 days of children in group home or residential placement, in addition to court hearings for approval. This is all new and should start October 1 with new requirements. Worry about the additional requirements on staff.
