- Additional parking lot lights has been installed at the dog warden's and 911 locations. We are having the tree's trimmed back to aid in the light distribution. H
- All the towers have been inspected. They have provided a couple of quotes for updating some cable runs at the jail for the amateur radio system. 5
- The security walls around the servers in the basement of the Sheriff offices is complete and the keys have been turned over to the I.T. department.
- We are working with the Sheriff Office with documentation for their state inspection. 4
- We are working with the sheriff office on installing new vending machines and tablet charging stations in the blocks. 5
- The Jail elevator controls up-grade is completed. There is some electrical, phones lines, elevator key lock-out, and fire alarm work to be done yet. 9
- The electrical for the Service Center Electronic sign has been installed.
- Scheduling with contractor on moving the phone and the data cables so they all terminated into their server room at the BOH.
- We have the quotes for the commissioner's building renovations. 6
- 10. The PO# for the air distribution system (diffusers and dampers) and air balancing for the BOH has been issued.
- 11. The antenna, cables, and 120v power has been installed for the C.H. help button system.
- 12. Habitec to install the fire alarm system cell to the BOE location by end of week. Testing and certification to follow.
- We are working with I.T., C.H. Security, Habitec, Electrical (cables and power) and mechanical contractors (doors and hardware) to enhance the courthouse and commissioner bld. security.
  - We have trees at multiple locations that need taken down or trimmed back.
- Cousino's Restoration have finished the flooring and painted all the door jambs. The cabinets and countertops have been ordered.
- PDG is working on finishing the drawings and bid specifications and get (everything in order) to bid out the JDC HVAC and controls project. I talked with Eric Thursday about this again.
  - A PO# for the windows and doors painting at the Jail has been issued.
