Board of DD	Sarah Zimmerman – Board of DD. Sarah came in for her regular meeting with the Commissioners and to review her 2024 budget. They had their three year accreditation scheduled and they received a perfect accreditation with no citations. She had shared a few months ago about moving the School of Hope under North Point Educational Service Center Management. As they need educational staff they are filling those vacancies through North Point. Starting in 2024 all school services will be contracted with North Point. It will be budget neutral, it will just move the expense to contract services rather than wages and benefits. They are in significant need of other staff. Sarah pointed out a few highlights on her 2024 budget. They are budgeting for the design and feasibility for building expansion. They do need more room. They had four students on a waiting list and did not have the room. There was discussion on the needs for early intervention and aids for students who need special assistance. October is National Disability Employment Month. There is a campaign and bill boards out in the community. September was National Direct Support Professional Awareness Month. 
